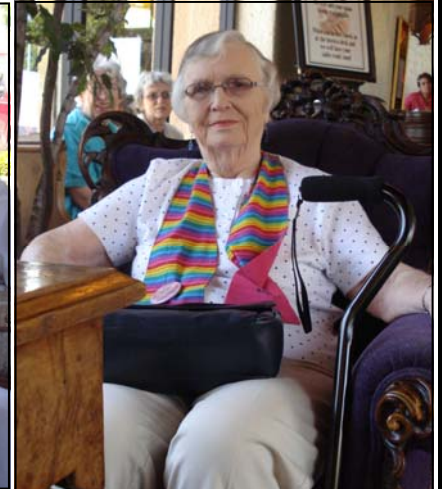

### A Note from your Treasurer

At our Annual Meeting this year we discussed the need for annual dues to help cover expenses such as this newsletter. We must pay for the printing and mailing, generally around \$500-600 per year. In the past this has been paid for by the interest earned from our Endowment Fund. This fund was established many years ago primarily as a scholarship fund for the annual retreat and luncheon. All first time retreat attendees are offered 1/2 off of the expense of coming to the Retreat and we must also pay for the leader's expenses. Some years cost more than others and some years earn more interest than others. The Endowment Fund is set at \$10,000 and we may only use the amount over that - currently \$13,149. We are asking for an Annual Dues of \$15 per person.

If you can afford it and feel that it is worth it to keep in touch with other Clergy Spouses through this newsletter. You may also donate directly to the Endowment Fund as a source of continued revenue for the Association. We are all in this Ministry together!

## MINUTES OF MEETING

### Remaining Focused

Let me begin this message by thanking everyone who attended this year's Annual CSA Meeting and Luncheon.

It was a joy to share with you my story, "Afflicted but Not Crushed." It was an additional joy to have my daughter and granddaughter at our Luncheon.

Webster's Compact Dictionary describes the word "Focus" as 1: point at which reflected and refracted rays meet. 2: Adjustment (as of eyeglasses) for clear vision 3: Central point brings to focus.

I visited my eye doctor a few weeks ago because my right eye was bothering me. He said that I have a bacterial infection in my right eye. Dr. Stanko gave me strict orders to use antibiotic eye drops six times a day. That meant I had to use the eye drops in the middle of the night. Eeeeks! He also insisted that I return each week for a checkup.

I explained to him that I would **focus** on the healing of my eye. However, I could not commit to seeing him each week for a check up. I would skip an appointment to **focus** on my Step-mother's 80<sup>th</sup> Birthday party in Los Angeles.

After the nine day trip, I returned to the Doctor's office. My eye was a mess. He said, "Carol have you been using your eye drops?"

"Oh yes," I replied.

"Well, I just don't understand.

Your eye was healing so well before you left. Continue using eye drops and please make sure you

follow my directions carefully." Of course, I thought I was.

My **focus** was now in high gear. I knew that I had three bottles of the eye drops. One bottle was in my purse. One bottle was in my travel bag. And one bottle was in my basket next to my bed.

As I laid down that night, I located my eye drops in the basket. I inserted one drop and closed my eyes for three minutes. Getting up, I went searching for the other two bottles. Now this is the truth.... I could not make up such a story. While **focusing** on the matter at hand, I discovered that the bottle in my travel bag and the bottle in my purse did not match the color of the lid on the eye drops I had been using on my trip. Oops!

During my trip, I was using a 2005 eye drop prescription for Glaucoma. Not my Doctor's prescription for the antibiotic. Eeeeks!

Was I so **focused** on other priorities that I made such a devastating error? I believe that God sends us messages to remind us to slow down and stay **focused**. My eye will eventually heal.

I threw out the old bottle of eye drops that I used on my trip. (by the way, the eye drops were so old that they did not cause harm) and I began using my prescribed antibiotics.

I'll see my Doctor next week. My eye should look much better by then. I know with God all things are possible!

*(Stories of a pastor's wife)*

We were married eight years when the call came. It was in the early 80's, my husband was called into the ministry. We had a beautiful life together serving the Lord at our local church. My husband was the Young Adult Sunday School teacher of our church. We lived in our own home with our sons. As far as we were concerned, our life was mapped out. It was wonderful. We had a strong Christian support group within the church. We celebrated much of life with this group. Our children were all about the same age. I felt like I knew what our life would be like within this community. We were comfortable, but God had other plans for us in calling my husband into pulpit ministry.

After debating with God for four years, my husband accepted God's Call. In preparation for our first appointment (two churches in the back hills of Kentucky), we stepped out on faith by selling our home and furniture and moving with our three sons (ages four months to five years). It was our first experience in being pulled in different directions between church and school. Both were absolutely necessary because one can not go to seminary unless first completing college. I was so sure that I would be received in the new churches as one of the girls, just the one married to the pastor.

Never in my wildest dreams did I think that I would be so set apart. It's as if "Pastor's Wife" was a universal label which shouted through the speaker system, "*Pastor's wife coming! Everyone! Stay clear!*" The daily routine was to treat the "Pastor's Wife" with some respect but to keep the mandatory distance away. This ensured that no actual-honest-to-goodness relationship bridges were extended to the "Pastor's wife" ("*Pastor's wife coming! Everyone! Stay clear!*") Has it actually been twenty six years since those first student churches? I laugh about those true experiences now-ok, I chuckle about them-ok, I giggle-ok, I grin-ok, you got me. I still shake my head in bewilderment. I wanted so much to be part of their lives as one of them. I have accepted that I will not be one of them. I am a "Pastor's WIFE!" ("*Pastor's wife coming! Everyone! Stay clear!*")

And yet it's very strange the way

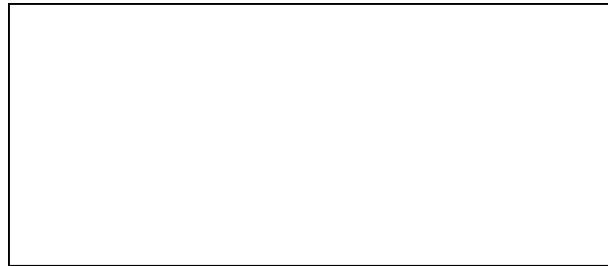
We think of them Thanksgiving day.
